This appliance must be installed, commissioned and serviced by a qualified person in accordance with national and local regulations in force in the country of installation.

Ensure that the plug/socket is accessible at all times.

Strip plastic coating and clean the appliance before use.

During operation parts may become hot - avoid accidental contact.

Disconnect this appliance before servicing, maintenance or cleaning.

## **INSTALLATION AND COMMISSIONING**

This appliance must be earthed.



An equipotential bonding terminal is provided to allow cross bonding with other equipment.

If replacing the plug connect the terminals as follows:

Green and Yellow wire Earth E
Blue wire Neutral N
Brown wire Live L

Supply cords shall be oil resistant, sheathed flexible cable not lighter than ordinary polychloroprene or equivalent elastomer sheathed cord (code 60245 IEC 57)

Install this appliance on a level surface ensuring all vents are unobstructed. Install this appliance on a level surface ensuring all vents are unobstructed. Any partitions, walls or furniture must be of non-combustible material. Minimum distances A 100mm B 1000mm – see Fig 1.



Only qualified or trained personnel should use this appliance.



Connect the unit to an electrical supply – the green neon illuminates to indicate power to the appliance.

Turn the control knob Fig 2 (B) to the desired setting – the amber neon illuminates and extinguishes when the set temperature is reached. The neon then cycles with the element operation.

The timer (A) allows an audible warning to be set, it does not control the elements. To switch off, use the control knob.

To check contents, pull the drawer out, ensuring it is held level until it locks in place. To remove drawer completely, pull forwards whilst tilting downwards.

This appliance is fitted with a safety thermostat which will prevent excessive temperature rise in the event of a fault. If the green neon lights but the element does not heat, the safety thermostat may need to be re-set by pushing up the button (C). The appliance needs to be cool before the safety thermostat can be re-set.

#### **CLEANING**



Do not use a water jet or steam cleaner, and do not immerse this appliance.

Clean all panels with warm water and mild detergent, do not use abrasive materials. Dry with a soft cloth.

## SERVICING, MAINTENANCE AND COMPONENT REPLACEMENT

All servicing, maintenance and component replacement on this appliance should be carried out by one of our recommended service engineers.
